# **Exhibitor Liability Insurance Program**

As a standard requirement for all our show exhibitors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$1,000,000 aggregate. <a href="Insurance-boverage">Insurance Coverage</a> is not optional.

This insurance must be in force during the lease dates of the event, May 6-15, 2026 naming International Carwash Association (101 S. Cross St., 2nd Floor, Wheaton, IL 60187) as the certificate holder. The following must be named as additional insured: International Carwash Association and Music City Center.

## **Rainprotection Insurance Program**

If you do not have insurance, or you would rather not use your own insurance, (similar to when you rent a car – so that claims would not be filed against your policy), we have set up a program with Rainprotection Insurance through which, you can purchase compliant insurance instantly online.
